In conclusion, it was reported that the overall performance of the Service continued to improve across the performance measures including key areas such as primary fires, deliberate primary fires and fatalities, matched by the increase in both the number of Home Fire Risk Assessments completed and improved targeting.

- 2. The current Basic Allowance of £3,912 including the 12% pension uplift, be approved.
- 3. The recommended Special Responsibility Allowance (SRA) for the Chairman of the Authority of £29,128 including 12% pension uplift, be approved.
- 4. The recommended SRA for the Vice-Chairman of the Authority of £13,104 including the 12% pension uplift, be approved.
- 5. The two positions of Chairman of the Strategic Committees be referred back to the Independent Remuneration Panel for further consideration in the light of the resolution under Item 10 of the agenda.

- 6. The recommended SRA for the two positions of Vice-Chairman of the Strategic Committees of £3,049 including the 12% pension uplift, be approved.

- 8. The recommendation to discontinue with the SRA for the Chairman of the Equality and Diversity Overview Group, be approved.
- 9. The recommended Co-optees Allowance for the Chairman of the Standards Committee at £595, be approved.
- 10. The recommended Co-optees Allowance for the two Co-optees of the Standards Committee and one Co-optee of the Audit Committee at £297, be approved.
- 11. The HMRC mileage rates, as detailed at paragraph 19 of the report, be adopted.
- 12. The subsistence rates, and conditions by which they can be claimed by Authority Members, be maintained on the current basis.
- 13. The possibility of permitting those Members with dependent children to access the Salary Sacrifice Scheme on the same basis as Officers of the Authority, be explored.
- 14. The following indices be applied to the remuneration and allowances paid to Authority Members:
 - a) Basic Allowance, SRAs and Co-optees' Allowances
 - Indexed to the annual percentage salary increase for local government staff (at spinal column 49) to be applicable from the start of the municipal year, rather than financial year.
 - b) Mileage Allowance
 - Indexed to the HMRC rates
 - c) Subsistence Allowances
 - The day subsistence allowances, overnight subsistence allowances and incidental expenses allowance be indexed to the consumer price index (CPI), rather than the retail price index
- 15. The 1-SRA only rule, where an Authority Member can only be paid one SRA regardless of the number of remunerated posts they may hold on the Authority, be approved.

- 16. The implementation of the revised allowances, as detailed above, come into effect immediately from this meeting.
- 17. The Clerk be authorised to amend the Scheme of Members' Allowances accordingly pending reconsideration of these allowances by the Independent Remuneration Panel, and thereafter by the Authority, the current special responsibility allowances contained in the Scheme of Members' Allowances shall apply.
