To recommend the appointment of two new Independent Members to the Authority's Audit, Scrutiny and Standards Committee and to agree the Term of Office that each newly appointed Independent Member is to serve.

## INTRODUCTION AND BACKGROUND

- 1. At the meeting of the Policy Standing Sub-Committee on 25<sup>th</sup> May 2006 delegated authority was given to the Treasurer and the County Fire Officer & Chief Executive to recruit Independent Members in consultation with the three Group Leaders to the Authority's Audit Committee.
- 2. At the last meeting of the Authority on 21<sup>st</sup> June 2012 it was reported that the current Independent Member on the Committee, Mr Ken Harper, had given notice that he was not seeking renewal of his appointment at the end of his term of office and the process to recruit two new Independent Members was underway. Mr Harper's term of office was due to come to an end on 10<sup>th</sup> September 2012 and it was agreed by the Authority to extend his appointment until the 30<sup>th</sup> September 2012 to allow him to attend the next meeting of the Audit, Scrutiny and Standards Committee on 27<sup>th</sup> September 2012 (Minute 9 refers).
- 3. An advertisement was published in the Manchester Evening News on 22<sup>nd</sup> May 2012 advertising the appointment of Independent Members to the Authority's Audit and Scrutiny Committee and the advertisement was also published on the Authority's Website and the AGMA Jobs Portal.
- 4. The closing date for applications was 13<sup>th</sup> June 2012. Shortlisting took place on 21<sup>st</sup> June 2012 and Interviews took place on 9<sup>th</sup> July 2012 which involved the Chairman, Councillor Dylan Butt, and Vice-Chairman, Councillor Derek Heffernan of the Audit, Scrutiny and

Standards Committee, Treasurer, Director of Finance and Technical Services and Democratic Services Manager.

### **CONCLUSIONS**

- 5. Following the interviews it is the recommendation of the Panel that Francis Walsh and Lisa Hindle are appointed as Independent Members to the Audit, Scrutiny and Standards Committee with their respective term of office of two years with an option to extend for a further two years. It is proposed to grant delegated authority to exercise this option to the Treasurer in consultation with the Chairman and Vice-Chairman of the Audit, Scrutiny and Standards Committee and Director of Finance and Technical Services.
- 6. The new Independent Members first meeting of the Audit, Scrutiny and Standards Committee would be 27<sup>th</sup> September 2012. An induction meeting has been arranged to take place on 14<sup>th</sup> September 2012.

#### RECOMMENDATION

7. To appoint Mr. Francis Walsh and Mrs. Lisa Hindle as Independent Members of the Authority's Audit, Scrutiny and Standards Committee for a 2 year period with delegated authority to the Treasurer to extend for a further two years subject to consultation with the Chairman and Vice-Chairman of the Audit, Scrutiny and Standards Committee and Director of Finance and Technical Services.
