1. AGMA FINAL OUTTURN 2019/20

- 1.1 The outturn position for the year ending 31 March 2020 shows an underspend of £305k. The position reported in February 2020 for Quarter 3 was a projected underspend of £71k. Due to the increase in the underspend the £50k contribution from reserves has not been drawn down.

- 1.3 As reported in February 2020, the costs for the Greater Manchester Spatial Strategy has been met from resources within the GMCA budgets, therefore the budget for 2019/20 was removed. A carry forward for the Spatial Framework from 2018/19 of £226k has been included in the underspend to be added to the AGMA General Reserve.
- 1.4 The underspend on GM Moving from of £25k was included in quarter 3 forecast and there has been a £9k increase to £54k in the underspend on the Police and Crime Panel.

2. RESERVES

2.1 The position at the end of 2019/20 has led to transfer to reserve of £255k increasing the reserve to £0.890m
