# *GM Business Board (LEP) – Existing Model*

---

- GM Business Board (LEP) is a private-sector led, voluntary partnership whose core function is to provide leadership alongside the GMCA to deliver the region's strategic ambitions
- It is co-terminous with GMCA and was established at the same time in 2011. Both bodies were designed to have a shared strategic vision and complementary roles from the outset, as set out in the original proposal to government
- GM's unique approach had the Board integrated into the heart the city region's governance arrangements, ensuring that business leaders are empowered to work with GMCA to set the strategic course, agree priorities, determine local priorities and drive growth and job creation within the city region.
- The Board consists of 15 members; 11 private sector members and 4 GMCA members which includes the Mayor and three GMCA representatives along with 2 'ex-officio' members
- The Board is led by Lou Cordwell as Chair and Cllr Bev Craig as Deputy Chair. The model reflects the Board's commitment to be a modern, collaborative and ambitious voice of GM business
- This is underpinned by joint ownership of the refreshed GMS along with the GM Local Industrial Strategy agreed and launched jointly with Government and the GM Economic Vision.

# *LEP Integration & New Model*

---

- Government LEP Review resulted in LEPs being integrated into local democratic institutions - announcement in the Levelling Up White Paper
- Now evolving towards a new model of a GM Business Board fully integrated into GMCA with a remit to ensure we can be as ambitious as possible, maintaining a strong business voice at the heart of city region and maximising economic growth across GM:
  - Contribute to current **GM economic thinking** and develop responses to any challenges/opportunities and feed into wider inclusive economic development work
  - Oversee **framework of key GMS priorities** agreed annually with GMCA
  - Lead delivery through **affiliated groups** in areas where GMCA is already allocating considerable resource
  - **Explore Foresight topics** that reflect the longer-term economic issues that will shape the city region e.g. AI
  - Provide **thought leadership** to influence at local, regional, and national level developing productive relationships with political and strategic decision-makers
  - Engage with **GM Districts** to strengthen connection and visibility, gather views/evidence from local business and support delivery of key district initiatives
- Waiting on approval from Government to take the next steps
