<p><b>The decision is that:</b></p> <p>The STRIVE contract is extended until 15<sup>th</sup> April 2022 whilst an exit strategy for STRIVE is finalised.</p> <p>The total funding for this is £119,832.71 for the period 2<sup>nd</sup> December – 15<sup>th</sup> April 2022.</p>
<p><b>The reasons for the decision are:</b></p> <p>GMCA awarded the STRIVE contract to TLC: Talk, Listen, and Change in December 2018. The service was initially commissioned for a period of 3 years and ended on 1<sup>st</sup> December 2021.</p> <p>Following an evaluation of STRIVE undertaken in 2020, discussions with the Deputy Mayor and key stakeholders, including GMP and TLC, it was agreed that options for remodelling the service would be explored between GMP, TLC and the GMCA. Options for remodelling were explored, however when we sought procurement and legal advice about these it was advised that options identified would require changing the scope of the current contract too extensively and have other legal ramifications.</p> <p>The Deputy Mayor has therefore agreed to extend the current contact until mid-April 2022 whilst an exit strategy for Strive is finalised.</p>

**Procurement comments:**

We have sought procurement advice and procurement have been involved in the conversions around extending the contract and finalising an exit strategy for STRIVE. An exemption form will be completed on procurement advice for the contract extension.

**Financial comments:**

£119,832.71 overall cost for extending the contract.

£106,517.96 will come from the MoJ Victims Core grant and underspend from previous years.

£13,314.75 will come from the MoJ Victims Core Grant for 2022/23.

**Legal comments:**

The contract states that an extension is allowed 'by mutual agreement of both parties, a date noy beyond the first of December 2023'. Legal have provided an agreement for both parties to sign up to to extend the contract.


