<p>The decision is that:</p> <p>The Deputy Mayor approves the award of a 3 year contract for the supply of temporary admin / clerical / IS roles, to Reed Talent Solutions, with the option to extend for a further 1 year. The likely value of 4 years spend would be circa £6.88m.</p>								
<p>The reasons for the decision are:</p> <p>Following competition Reed Talent Solutions emerged as the preferred supplier.</p>								
<p>Alternative options considered and rejected:</p> <p>In accordance with procurement legislation the highest scoring bidder, using the published criteria, has to be selected.</p>
