Introduction

Background

The idea behind the Greater Manchester Youth Combined Authority (GMYCA) emerged from young people in 2017.

Following this, the GMYCA was formalised by the Mayor of Greater Manchester (Andy Burnham) and the Greater Manchester Combined Authority (GMCA) in 2018, supported by the ten Local Authorities in Greater Manchester.

The Youth Combined Authority held their first meeting in February 2018.

The aim of the Youth Combined Authority is to give young people in Greater Manchester the opportunity to have their voices heard and influence GMCA policy and decision making.

Its purpose is to:

- **Advise the Mayor and GMCA on key issues and concerns of young people, and provide solutions;**
- **Provide a critical voice and scrutinise the work of the Mayor and GMCA;**
- **Undertake specific pieces of work**

Organisations apply for seats based on a spread of geography and identity.

The term of office is two years, of which the current term for members will complete in December 2021 with plans to recruit a new cohort for 2022-24 well underway.

The current cohort has listened, grown, amplified and worked on complex projects. The GMYCA have created space to share concerns as well as offer advice on a variety of topics.

The GMYCA has worked with elected officials including the Mayor of Greater Manchester, and other key stakeholders such as Transport for Greater Manchester (Tf)GM alongside consultants like Hitch. (There is a full list of officials listed in Appendix 1).

Youth Executive Summary

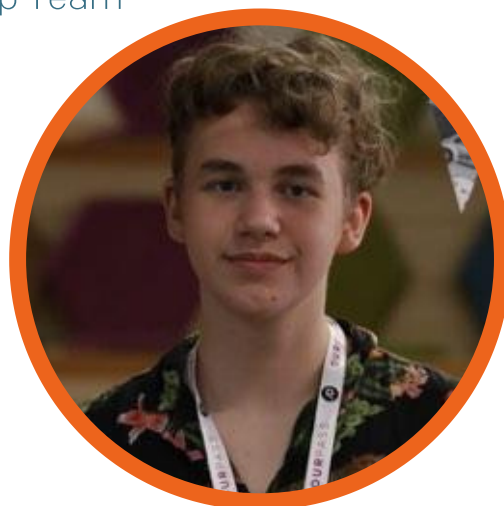
The GMYCA has been heavily involved in the creation of Our Pass and our involvement hasn't stopped there. Many of our members went on to become ambassadors to the scheme, continuing to meet frequently with the Our Pass team and contribute to its development. In addition, we have worked tirelessly on the GM Green Summit, the Clean Air Plan and some of our members were also involved in the Young Person's Guarantee.

The GMCA has brought forward 'loads of opportunities' for us to have our views heard about topics; including the intention to introduce Police School Engagement Officers in schools. This created a lot of debate both internally and externally and this is exactly the type of debate we hope to continue as we go forward.

The establishment of our Leadership Team has also been significant. I am one of five members who have been democratically elected by our peers into positions of leadership. Together, the five of us meet regularly to plan meetings and set direction. The Leadership Team has given us great power to steer the group ourselves so that we can truly represent young people. The idea was suggested to us by YFNW and the idea went to a vote. We voted for the roles, and in October those who wanted to stand were encouraged to make a short video. The GMYCA members voted in a first past the post voting system. The leadership team consists of a Chair, Secretary, Digital Inclusion Officer, Communications Officer and an Inclusivity Officer. The Leadership Team is a diverse group of young people, some of whom have disabilities, are from different Ethnic backgrounds and we all come from a variety of youth groups.

Our journey as representatives

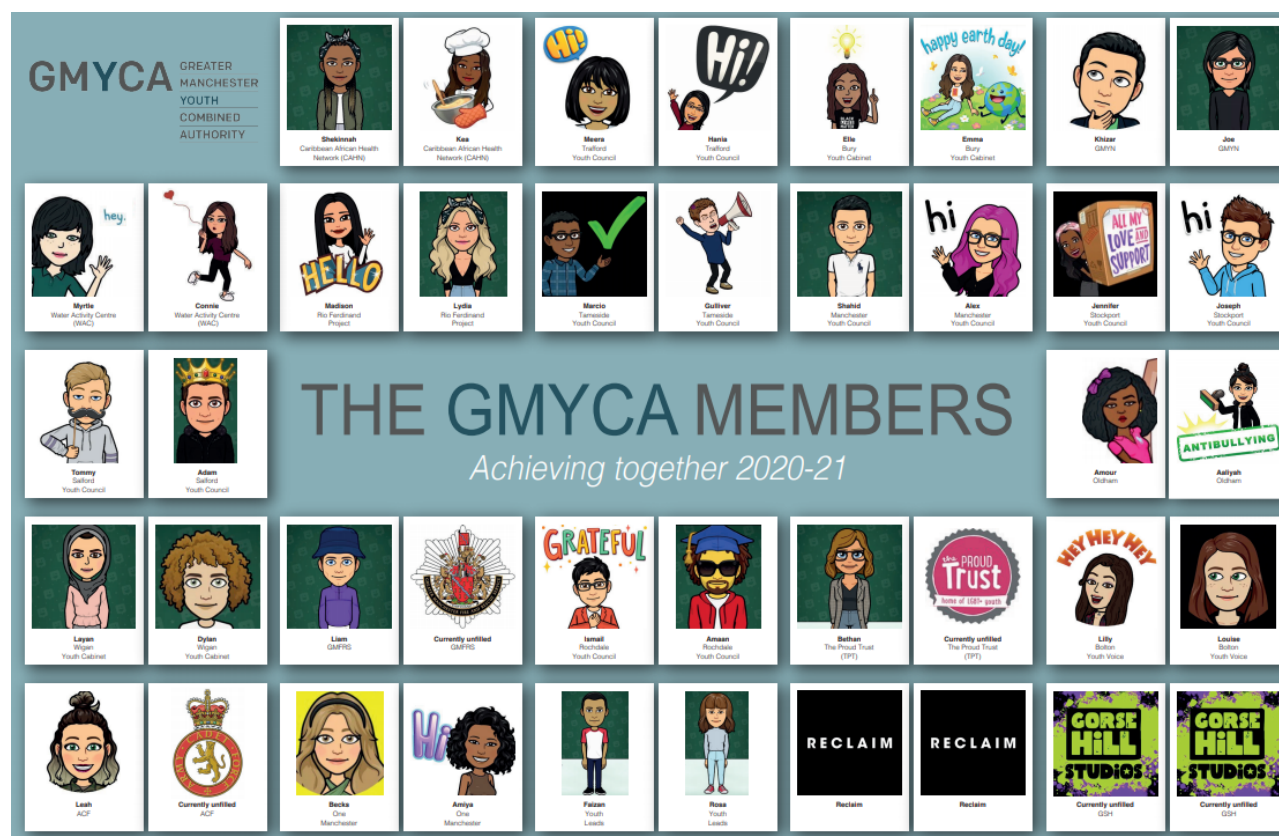

Overview

The new membership intake has included organisations that weren't part of the original youth combined authority, such as Rio Ferdinand Foundation and Caribbean and African Health Network (CAHN).

The new organisations have helped the GMYCA in ensuring that young people from a variety of different backgrounds get involved.

We believe that we are reflective of Greater Manchester, and to show this we have created a poster to show our diversity:

We are proud of the diversity represented within the GMYCA, although we are aware there are some gaps. We will look to fill these gaps and ensure the GMYCA welcomes as diverse a group of young people as possible in its next cohort.

To date we have held 21 main meetings, 16 environmental group meetings, 22 leadership meetings and 5 meetings with the mayor. (see Appendix 1 for a full breakdown)



Development Days

In order to help with the personal development of members, we hold a number of development days throughout the year. The first of five helped us to develop our skills in representation, team building and being critical thinkers. February's session was focused on stretching ourselves and coming out of our comfort zones. We spent the day at 'Challenge for Change' in Trafford taking part in team-building activities.



Adapting to digital

Since April 2020, we have moved all of our sessions online due to the COVID-19 pandemic. However, this hasn't stopped us from growing as a team and continuing with the important role we have as youth representatives.

We've had lots of "adventures" with technology during the pandemic; we've tried new ways of working and we seem to have mastered Zoom! We feel that using breakout rooms and other tools has enabled us to create new ways of working and this will affect how we continue to work moving forward.

The YCA has provided me with endless opportunities to use my voice as a young person. This has boosted my confidence levels and built my ability to make meaningful connections with different groups of people in Greater Manchester. Becoming the Inclusivity Lead of the GMYCA has been an honour and an amazing learning experience; from leading icebreakers, engaging in discussions with the Mayor, to speaking with other youth organisations- it has truly taught me that I can be impactful and so can you! It only takes you to realise the power that your voice carries.

We have implemented a system whereby when guests attend our meetings they send us information about their topic in advance, we call this a 'one-page profile' and we think this has enabled us to be more prepared and knowledgeable before the session.

We have also challenged language, and how adults speak to young people. This includes senior decision-makers within the GMCA.

Examples of our work

The Green Summit

We formed an 'Environment Working Group' to work specifically on the environment, the young people were asked to come up with themes to help the summit be informed by young people. Due to the pandemic, the Green Summit had to be held online over 5 days. Young people were passionate about this work and quickly moved from in-person meetings to meeting online in a group and on a 1-2-1 level with YFNW to help bring the event together. The project changed dramatically as a result of COVID, which brought positives, allowing the young people to work remotely, but it was difficult at times to write and record sessions purely from home. Despite very tight timescales, we were able to meet outdoors briefly to record sessions and develop content that played a key part in the summit's schedule.

Knife Crime - Working with Hitch

We worked with Hitch, the design agency, to develop the "Violence isn't me" campaign. We met with Hitch to help shape the project and provided our views on wording, images and platforms that could be used to amplify its important message.

GMP School Engagement Officer Proposals

Greater Manchester Police's proposals to introduce dedicated officers in some schools in Greater Manchester has been an important and, at times, a controversial topic for the GMYCA this year. We have met with decision makers, as well as senior GMP and GMCA officers to challenge this policy and express our views. As a group, we felt the proposals would have benefitted from greater input from young people.

After around 15 meetings on the subject across the first half of 2021, we are pleased that our voices have been heard and further work is being done around the policy including information being provided to young people and a panel being set up to scrutinise the process.

Recommendations and final thought from Youth Focus North West (YFNW)

The GMYCA was the first established Youth Combined Authority in England and it continues to be the strongest, based on its structure, reach and impact.

Its evolution over the last four years is at a point where the members now feel comfortable to meaningfully challenge decision-makers in a mature and respectful way. The most significant showing of this is their stance on 'Police in Schools'.

As the GMYCA evolves, so does the wider picture of children and young people's voice across Greater Manchester, and it is important that the current journey of recognising, celebrating and collaboration continues.

The GMYCA is now looking at what young people say across Greater Manchester by pulling in evidence. Examples of this can include activities such as the Greater Manchester Mayoral Hustings.

YFNW has been the commissioned partner of the GMYCA since 2017. We have had the privilege of watching the GMYCA grow. However, none of this would be possible without the continued help and support from the ten Local Authority Youth Services and eleven wonderful voluntary sector youth providers that we work with. We have continued to develop relationships with services within the Youth Work sector, through quarterly gatherings and one-to-one meetings.

To further develop we recommend that:

- **Communications to promote the GYMCA and its work are enhanced;**
- **A new approach to membership is developed for the next cohort. Consider the age groups (11-14 yrs) and (18+), SEND, and widening out organisational membership;**
- **Continue with the Leadership Team roles and enable other young people to lead on themed areas;**
- **The GMYCA works on themes already identified by young people from across Greater Manchester: Health and Wellbeing, Covid Recovery, Equity and Equality, The Environment, and CYP Voice;**
- **That the GMYCA creates its own manifesto for change which runs concurrent to the Mayor's term of office**
