The decision is that:
In Line with our partnership bid, the Named Local Authorities have been allocated, funding to deliver interventions to that address Domestic Abuse perpetrator offending.

The reasons for the decision are:
<p>Greater Manchester Combined Authority were successful in receiving a grant from the Home Office for Domestic Abuse Perpetrator work.</p> <ul style="list-style-type: none"> • £992,050 for Bid 1- to support general perpetrator interventions • £524,499 for Bid 2- to support child and adolescent interventions. <p>The funding is aimed to increase the geographic expansion of programmes and the target cohort through adaptation of programmes to reach wider needs.</p> <p>Grants will be provided to PCCs as the lead partner, but the expectation is that PCCs will deliver the intervention in collaboration with a partner organisation.</p> <p>The funding period will be from 1 August to 31 March 2022.</p> <p>GMCA received expression of interest from Local Authorities and as such the GM Bid was formed.</p> <p>The Home Office have now issues grant agreements (annex 1) which the GMCA will need to report back on.</p> <p>As a part of the bid that has been accepted by the home office it was agreed that Local Authorities within GM would be the partner organisation.</p>

- **GMCA have allocated £167, 000 Bolton for adult interventions,** For Bolton to Commission, TRAC Psychological (Inner Strength) to deliver a range of perpetrator programmes including expand Inner Strength: strength-based therapeutic interventions for perpetrators & victims

- **GMCA have allocated £335,000 Bury Interventions**

£185,000 for TLC: Talk, Listen, Change to deliver the Drive Programme, this funding will be paid directly to TLC to extend current Drive provision into Bury

£100,00 for Bury for adult interventions,

- For Bury Council to Commission TLC to deliver a range of perpetrator programmes, New DAPPs for men in heterosexual relationships & adapted 121 programme for ESOL & those in gay & bisexual relationships

£ 50,000 For Children and Young people interventions

£ 87,000 For Children and Young people interventions,

- For Oldham Council to commission TLC to deliver, Child Respect Young People's Programme for CYP (children & young people) age 10-16 abusive or violent towards parents/carers.
- For Oldham Council to commission TLC to deliver, Child TLC Healthy Relationships Programme adapted & shortened version of TLC's DAPP (behaviour change programme), for CYP age 10+ violent towards intimate partners / peers.

- **GMCA have allocated £234,000 for Rochdale for adult interventions,**

£135,000 for TLC: Talk, Listen, change to deliver the Drive Programme, this funding will be paid directly to TLC to extend current Drive provision.

For Children and Young people

£31,039 for Rochdale to commission a VCSE provider to deliver Child to Parent Abuse and Intimate Partner Abuse and £68,960 for the Early Help Team to also deliver Child to Parent Abuse and Intimate Partner Abuse a total of – **£99,999**

£245,000 for adult interventions,

High risk perpetrators - Expand Roots Tenancy Support & Compliance Service (for MAPPA & PPO high-risk offenders) to work with perpetrators

- For Tameside Council to Commission TLC to deliver a Child to Parent Abuse programme Respect Young People's Programme for CYP (children & young people) age 10-16 abusive or violent towards parents/carers. Covers: Insight into violence & abuse & its' effects, Emotional regulation, Solution focused work & goal setting

- **GMCA have allocated £147,000 for Trafford Interventions**

£60,000 for Trafford to allocate to adult interventions,

- Make a Change Perpetrator Programme

£ 87,000 For Children and Young people interventions

- For Trafford Council to commission TLC to deliver, Child Respect Young People's Programme for CYP (children & young people) age 10-16 abusive or violent towards parents/carers.
- For Trafford Council to commission TLC to deliver, Child TLC Healthy Relationships Programme adapted & shortened version of TLC's DAPP (behaviour change programme), for CYP age 10+ violent towards intimate partners / peers.

This decision will contribute to priorities of the the Greater Manchester strategy in the following ways:

Links to Police and Crime Plan:

Priority 1 – contributing to reducing victims of violence, increasing feelings of safety, and increasing confidence in community safety.

Priority – Preventing violence, and the precursors to violence such as ASB. Intervening early to reduce the harm caused by violence.

Priority 3 – Supporting community resilience by investing in local services and people.

In addition, this piece of work links closely with the national Violence Against Women and Girls (VAWG) Strategy and the Greater Manchester Gender Based Abuse Strategy which is in development. Strategic pillars of these strategies include prevention, provision of services, partnership working, and pursuing perpetrators.

Financial comments:

The Home Office have confirmed that GMCA have been successful in securing £1,516,549 which will be issued as a grant payment to GMCA.

Project Name: Domestic Abuse: General, Stalking and Adolescent Perpetrator Programmes Fund

Project Reference: 188

Project Description: Greater Manchester Police and Crime Commissioner (PCC) intends to facilitate the provision of Adult Domestic Abuse Perpetrator interventions across Greater Manchester in Bolton, Bury, Tameside, Trafford, Rochdale, and Oldham Local Authorities (LAs). They will sponsor the LAs to commission Talk, Listen, Change (TLC), ROOTS and TRAC Psychological

(together referred to as 'providers') to deliver the work.

as fully detailed in Schedule 1 and Annex D (the "Purpose").

1. Introduction

1.1. The Authority is exercising the power conferred to it by Section 169 of the Criminal Justice and Public Order Act 1994 to make awards of grant

funding.

1.2. This agreement (the “Grant Agreement”) sets out the legally binding terms and conditions which apply to the Authority providing the Grant and to the Recipient receiving the Grant. It consists of twenty-four (24) Clauses, seven (7) Schedules and eight (8) Annexes.

1.3. It is supplementary to the Grant Funding Letter (as defined below) and replaces any previously agreed grant terms and conditions for between the Authority and the Recipient to introduce new perpetrator interventions locally.

1.4. The Fund will positively impact on perpetrators and victims of domestic abuse in both England and Wales. Resultantly, the Recipient, Delivery Partners and Project Implementation Partners must be cognisant of, and act in accordance with, any devolved policy bulletins, enactments, orders, statutes, regulations or other similar

instruments as appropriate. For example, where the Purpose is delivered in Wales, whether wholly or partially, it must be provided in such a way as to not treat the Welsh language less favourably than English, in accordance with the Welsh Language (Wales) Measure 2011.

Risk Assessment:

To ensure appropriate spend of the grant, local authorities will be asked to provide monitoring returns to document the spend. Additionally, the monitoring returns will seek to evidence the positive impact seen as a result of the grant. Regular contact will be maintained with the grant holders to address any issues and ensure we are able to maximise any opportunities to share good practice and learning between partners.

Is safeguarding of children relevant and has this been considered:

Safeguarding of children will continue to be a key aspect of service delivery for services we grant fund and will be dealt with using the agreed protocols.

Is safeguarding of vulnerable adults relevant and has this been considered:

Adult safeguarding will continue to be a key aspect of service delivery for services we grant fund and will be dealt with using the agreed protocols.
