


Key Decision

Urgent Key Decision

Notification by the proper officer (Chief Executive/Monitoring Officer/Treasurer) to the scrutiny chair that an urgent key decision be made without being published in the Register of Key Decisions, and/or that key decision be exempt from call in for scrutiny.

Decision maker	Chief Executive Officer GMCA and TfGM, in consultation with the GM Mayor.	
What is the decision?	<p>Allocation of City Region Sustainable Transport Settlement (CRSTS) interim funding by the Chief Executive GMCA and TfGM.</p> <p>In January 2022, GMCA delegated to the Chief Executive GMCA and TfGM approval and submission to Government of the CRSTS Programme Case.</p> <p>The Department for Transport has indicated that an announcement on Greater Manchester's final CRSTS allocation is unlikely to happen until later this year. However, DfT informed TfGM in March 2022 that GMCA will receive an interim award for elements of the programme that need to start in April 2022. Therefore, GMCA has been recommended to delegate approval to the Chief Executive Officer GMCA and TfGM, in consultation with the GM Mayor, to enable the allocation this 'interim' funding, in particular, the Highways Maintenance element as soon as it is confirmed.</p> <p>This notification is for any decisions the Chief Executive Officer GMCA and TfGM may make with regarding allocations of CRSTS funds, subject to delegation by GMCA.</p>
