#### Question 2

What is the main aim and purpose of the activity?

The activity consists of a public consultation on the Greater Manchester Combined Authority's (GMCA) proposed franchising scheme, which is set out and considered in an assessment prepared by TfGM on behalf of the GMCA.

The overall aim of the activity is to undertake a consultation that meets the requirements of section 123E of the Transport Act 2000 (as amended by the Bus Services Act 2017) (the Act). This would be done by obtaining the views of a wide range of stakeholders (some of whom the GMCA are required to consult by the Act) on its proposal.

An Equality Impact Analysis of the proposed franchising scheme (distinct from the present document) has been produced and will form part of the subject matter of the consultation.

### **Question 3**

List the main elements of the activity. (for strategies list the main policy areas):

- Publication the Act requires the GMCA to publish various materials in undertaking a
  consultation. This would include a consultation document, the assessment, an
  auditor's report and a notice of the proposed scheme. These materials would be
  published online and hard copies of the same would be available in various locations
  across GM.
- Communication information messages giving details of the consultation via different forms of media.
- Stakeholder engagement contact and engagement with a variety of stakeholders as part of the consultation process.
- Consultation various activities to give people across GM the opportunity to have their say on the proposals.
- Deliberative research undertaking an additional activity to arrange for focus groups to consider the proposals.

## **Question 4**

If this is a new/proposed activity or a change to an existing activity please explain why the proposal being made for what reason?

On 30 June 2017, the GMCA decided to use the powers available in the Act to prepare an assessment of a proposed franchising scheme, which was completed and subsequently approved by the GMCA on 28 June 2019. Subject to the GMCA obtaining a report from an independent audit organisation on its assessment and subject to the GMCA wishing to proceed with the proposed scheme upon consideration of that audit report, the next step would be for the GMCA to undertake a consultation. It is therefore proposed that subject to the above, TfGM would undertake a consultation on its proposed franchising scheme on behalf of the GMCA. This would be a new activity.

### **Question 5**

What outcomes does the activity aim to achieve?

- To present the proposal and other required materials to the widest range of people, including those persons GMCA are required to consult by the Act across GM;
- That all stakeholders are provided with an opportunity to engage with the proposals and respond to the consultation;
- That all responses will be taken into account when reporting on the results and outcome of the consultation; and
- That the GMCA and the Mayor of Greater Manchester are presented with the results and outcome of the consultation as may be required under the Act.

Those beneficiaries are: the travelling public and Greater Manchester residents more generally; existing and potential Greater Manchester businesses; and existing and potential Greater Manchester bus operators / suppliers / employees.

No. TfGM has extensive experience of consultations and of the measures needed to accommodate groups with protected characteristics.

## **Preamble to response to Question 8**

Consultation is inherently positive – it is unlikely that inviting someone to comment on a proposition will have adverse effects on them. It is possible that members of some groups with protected characteristics are at a higher risk than the general population of being unaware of the consultation, of not being able to understand it or of being unable to effectively communicate their views. Where this is the case, measures to ameliorate these risks are noted under Question 8.

By way of context for Question 8, the following actions, of relevance to many of the protected characteristic groups, will be undertaken:

- the consultation document will be written in plain English and a plain English review of the summary will be undertaken before its publication;
- the consultation document will be augmented with additional explanatory and illustrative material, including appropriate visual material;
- printed consultation document summaries and response forms will be made available
  in accordance with TfGM's working practices on inclusive communication. This will
  include copies being made available in public buildings across GM, in relevant
  neighbouring authority areas and through public information stands;
- audio and large print versions of the consultation document will be available upon request;
- TfGM will be providing information stands, public drop-in events and a telephone
  helpline for those who wish to talk to us face-to-face, including those who may be
  unable to read our written material or to respond via our response channels, for
  example because of a disability;
- public events organised by TfGM will take place in fully accessible venues.

A number of response channels will be provided:

- respondents will be able to use the online consultation web address, where questions can be answered online or downloaded;
- it will be possible to scan and email hard copies of the response form or return it to a freepost address;
- anyone who cannot respond via the channels above or wishes to obtain a different format of the consultation will be able to email or phone the consultation team to discuss their individual requirements; and
- there will also be a shorter version of the questionnaire for people to complete.

A dedicated language line will also be set up to assist people who might require it.

In addition, a market research company has been engaged to carry out independent deliberative research (focus groups and workshops) to supplement responses submitted as a result of to the consultation material and associated publicity. A cross-section of the population will be recruited, and this will include people from groups with protected characteristics.

# **Preamble to response to Question 12**

The purpose of monitoring is to identify the emergence, as responses to the consultation are received, of any under-representation of protected characteristic groups in order that

corrective action can be taken. However, there are several practical difficulties with monitoring:

- The personal characteristics of people who respond by letter or email are unlikely to be known, other than possibly gender.
- Where people fill in a form, it is only possible to capture the broadest characteristics
  of respondents (age, disability, gender and race) since to do otherwise would risk
  deterring or alienating respondents with a long-list of detailed questions.
- There is no reliable yardstick against which to measure the aggregate profile of respondents. Even assuming equal awareness, understanding and ability to respond, it is unlikely that the profile of respondents would match that of the general population (and in some cases, the characteristics of the latter are unknown e.g. sexual orientation).
- The volume of responses to consultations tends to be low in its early stages, making any assessment of the emerging profile even more unreliable.

For these reasons, only high-level monitoring will be undertaken (on a weekly basis) to identify issues of clear concern.
