<p>The decision is that:</p> <p>The VRU are seeking to award Media and Digital Ltd (MaD) £392 for the purpose of printing a further 10,000 business cards to promote the Navigator service in Greater Manchester.</p> <p><i>To date, the VRU have awarded Media and Digital £392 in financial year 2022-23 for the previous printing of an initial run of 10,000 Navigator business cards. The total awarded by the VRU to Media and Digital following this decision will be £784.00</i></p>
<p>The reasons for the decision are:</p> <p>The cards will be given to frontline officers in the Operation Venture team, youth workers, and Navigators working in hospitals and the community to give out to young people who they think might need/be interested in the service. The cards will contain the Navigator and VRU logo, with a very brief description of the service, and a QR code to take people to the referral page.</p>

A one-off payment will be made to Media & Digital Ltd for the above services and will be funded out of the GM VRU's 2022/23 Serious Violence fund, Communications and Engagement Budget Line


