The GMCA are seeking to pay Think Different Events **£742.80** to cover the registration fees for Greater Manchester Violence Reduction Unit Director and Assistant Director (Police, Crime, Fire and Criminal Justice), to attend the Serious and Organised Crime Exchange's (SOCEX) annual conference on 9<sup>th</sup> - 11 October 2023. This fee will cover the following;

### The reasons for the decision are:

This year's conference titled 'Delivering an agile response to SOC in an increasingly unstable global context' will be hosted over three days (9<sup>th</sup> and 11t<sup>h</sup> October 2023) in Stratford-Upon-Avon.

This event provides attendees with the opportunity to listen to a series of guest speakers linked with the Serious and Organised Crime agenda as well as a chance to network and find out what programmes of work are being carried out across the UK.
