#### The decision is that:

£10,000 is approved to commission SMSR Research Ltd to conduct community consultation and engagement for the 'Another Chance' programme.

#### The reasons for the decision are:

The 'Another Chance' programme is a Youth Endowment funded programme which is currently in mobilisation phase, and due to begin offering support for young people from July 2023. The programme engages young people involved in a group dynamic with a risk of committing violent offences. The programme is specifically targeted at the communities in Central Manchester and North Trafford. Community consensus and support is vital in delivering a service within the community.

This work will engage with community members and other programme stakeholders to both inform of the proposed service and establish where further consultation and community involvement is required.

GMCA engagement team do not have current capacity to facilitate this engagement in the timeframes required.

#### **Procurement Comments:**

Advice sought and requirement to obtain 3 competitive quotes from potential suppliers. (value not exceeding £10K)



SMSR Research – Provided comprehensive bid based on specification. DGS Research – Unable to complete within timeframes required. BMG Research – Provided limited bid which only considered online consultation.

As such, a competitive process has been conducted and SMSR chosen due to the variety of engagement techniques and stakeholder engagement demonstrated.

# Financial comments:

£10K for this work was budgeted for in initial grant allocation- held within budget code 3040

# Legal comments:

Competitive process followed.

Any further consultation work connected to this programme will be subject to further competitive process.

GMCA standard terms and conditions will apply.

Due to short term length (12 weeks) and value (£10K), no contract will be required.

SMSR are a previous research supplier for GMCA with excellent track record. No risk perceived.
