To seek GMCA approval on organisations to be funded from the new GMCA Culture Fund 2020-2022, which will support delivery of the Greater Manchester Culture Strategy and Greater Manchester Strategy.

#### 1. PROPOSED GMCA PORTFOLIO

- 1.1 Appendix One proposes a final balanced portfolio of applicants to the new Spirit and Sustain strands of GMCA Culture Investment. This portfolio funds the highest ranked bids and ensures a balanced portfolio of investment across geography, art form, scale and diversity, recognising the changing cultural sector and needs of our residents.
  - Where organisations are of strategic benefit to Greater Manchester, but their applications didn't sufficiently demonstrate value for requested amount (Arts at The Mill, MancSpirit and Global Grooves) it is recommended that we make reduced offers. Agreed delivery will reflect the amount awarded.
  - GM Arts has undergone a period of organisational development over the past year, refining and focussing their offer. This has resulted in a reduced ask of £200,00 (previously £306,000 p/a) for a reduction of grant of £100,000
  - In 2022 The Turnpike CIC (part of the 2020 Culture Portfolio) ceased trading, with management of the gallery taken over by Wigan Council so did not submit an application to join this portfolio.
  - Since applying Oldham Coliseum has confidentially indicated that it will
    investigate orderly winding up the organisation in early 2023. This means
    that Oldham Coliseum will leave the GM Culture portfolio. However, given
    the strategic importance of Oldham Coliseum to Greater Manchester we
    recommend offering £50,000 p/a to the organisation that replaces
    Oldham Coliseum and will work with Oldham Council and Arts Council
    England on developing and supporting that alternative provision
  - It is recommended that four currently-funded Spirit organisations, who
    either did not request an increase in investment, or who didn't articulate a
    compelling case for an increase (The Met, Bury, The Lowry (Quays
    Culture), Comma Press, Wigan Steam) are offered standstill funding, with
    negotiated delivery to reflect amount awarded as required.
  - As the three Sustain organisations requesting more than £200,000 p/a
     (Halle, People's History Museum and Royal Exchange Theatre) are able

to access high-value schemes like Orchestra, Theatre and Museums Tax Relief, it is recommended that all are offered standstill funding. Agreed delivery will reflect the amount awarded as required.

- Based on scores and delivery of activity not currently delivered by the GM
  Culture Portfolio it is recommended that seven new high-scoring,
  strategically important organisations are brought into the portfolio.
- It is proposed that 22 currently-funded organisations in the Spirit pillar, who made a compelling case for an increase, will receive an annual increase of up to 10%, recognising that many currently-funded organisations have not received an increase in investment in more than five years.

#### 1.2 New organisations recommended to enter the portfolio:

#### **Headspace Bolton**

An exciting & innovative arts organisation, run by and for peers with lived experience of mental health and neurodiversity.

#### **Sounds From The Other City**

Salford based music and talent development programme culminating in an annual festival on Chapel Street described as the Christmas Day' of the independent creative scene

#### Muslim Arts and Culture Festival (MACFEST)

Annual festival of Muslim art and culture that promotes community cohesion, social inclusion and works to eliminate divisions in society

#### **Odd Arts**

Manchester-based Innovative theatre organisation that increases equality, opportunities & wellbeing for those facing complex barriers.

#### **Portraits of Recovery**

Oldham-based visual arts company working to promote and advance the health and wellbeing of the public, particularly people affected by addiction to drugs or alcohol

#### **Grit Studios**

Creative organisation based in Stockport providing affordable co-working spaces for artists with a commitment to embedding creativity in communities across Greater Manchester

#### **Made By Mortals**

Tameside-based creative organisation that cultivates communities of creative citizens. These communities that include professional artists, health and social care practitioners, commissioners, researchers, and experts by experience
