The Deputy Mayor agrees to pay Merseyside OPCC the sum of up to £22,000 for costs associated with the post of Regional OPCC Programme & Policy Manager, which are divided equally between the 5 OPCCs and GMCA.  4th September 2023 – March 2025 estimated to be in the region of £22,000.					
The reasons for the decis	ion are:				
The GMCA works closely with the five OPCCs in the Northwest region (Merseyside, Lancashire, Cheshire, Cumbria and North Wales) and have jointly agreed to establish the post of Regional OPCC Programme and Policy Manager in order to co-ordinate and lead on collaborative work in the region.

It has been agreed that Merseyside PCC is the host employer on behalf of the other OPCCs and GMCA.

A competitive recruitment process was led by Merseyside, following agreed recruitment practices.

There has been no procurement process.

#### Financial comments:

Based on the £6270 for 7 months this equates to £896 per month for 23/24. There will be a pay increase in 24/25 plus on costs and estimate total costs to March 2025 to be in the region of £22,000.

### 2023/24:

£6270/7 = £896 per month

#### 2024/25:

 $896 \times 12 = £10752$ 

Plus, on costs (estimate at 24%) = £2580

= £13332

Plus, provision for pay award at 2.5% = £333

= £13,665 (estimate for 24/25)

These costs will be set against CC 3004 up to March 2025.
