The venue (as previous years) will be Haydock Racecourse, including refreshments, 4 speakers, PA System and handheld microphones.</p> <p>Due to GMCA having the responsibility for hosting the payment of £6,327.60 will be met by the PCC team and then recharged to the 6 regions – Cheshire, Merseyside, Lancashire, Cumbria, North Wales who will then subsequently be invoiced at a cost of £1054.60 each.</p>
<p>The reasons for the decision are: This decision reflects our commitment to the ongoing support of the training, learning, development, support, and networking of the ICV volunteers.</p>
<p>This decision will contribute to priorities of the Greater Manchester strategy in the following ways: Providing input into relevant different topics and showing appreciation by delivering the conference will increase knowledge and encourage high morale thus continued commitment to the ICV role to continue to deliver a statutory function, This in turn, will contribute towards our GMCA values, which are, Collaborating, Empowering and Delivering, which will support us in meeting our GM strategy of - Safe and Stronger Communities – protecting vulnerable people and maintaining, public safety.</p>


