#### 1. BACKGROUND

1.1 The Police and Crime Panel and Steering group share a joint work plan that was agreed at the Police and crime panel on the 16<sup>th</sup> December 2020.

1.2 The workplan set out the areas of focus for both Panel and Steering group, with Panel receiving reports on those highlighted in yellow and the remainder for Steering group.

#### 2. DEVELOPING A FORWARD PLAN

2.1 Recognising the initial engagement process that had been undertaken in the development of the workplan, the areas of focus have been developed into a draft forward plan for the Panel and Steering group for 2022 – 23.

a. The forward plan will also take account of the priorities and work stream in the refreshed police and crime plan 2021-2025 once it has been issued.

b. The 2020 forward plan has been circulated to all police and crime panel members and lead community safety officers for comment.

## 3. FEEDBACK

3.1 Following a period of consultation with members of the panel and lead community safety partnership officers, the content of the workplan has been supported overall.

3.2 Proposals to incorporate additional work items are set out below to be considered by the panel members.

- i. Within the work plan, the theme of domestic abuse is incorporated into Gender Based Violence. It has been suggested that consideration be given to identifying domestic abuse as a separate workstream.
- ii. That HMICFRS VSA updates be scheduled into the plan.

#### 4. NEXT STEPS

4.1 The attached forward plan includes suggested and approximate dates for Panel, Steering group and Leads for the period 2022-2023 and aligns areas of focus.

4.2 Following approval by the panel, the forward plan will then be used to schedule meeting agendas in consultation with the Chair of the Panel.
