AQC 21/49 GM CLEAN AIR PLAN - MARCH 2022 UPDATE

Consideration was given to a report that provided an update on the scope of the review of the Clean Air Plan and the participatory policy development approach, as well delivery arrangements, including signage and funding.

The following comments were made:

Members were advised that the final proposals on the proposed way forward and impact assessments would be formally reported to GM authorities in June 2022, prior to 1 July submission to the Secretary of State.

In progressing the review, the development of the new policy would ensure relevant vehicle owners and their representative bodies would be provided with the opportunity to influence any revised and existing financial support packages.

It was noted that GM authorities would continue to seek to ensure that government takes appropriate action in relation to the A628/A57 Strategic Road Network to ensure the

benefits to the health of the residents in the villages of Hollingworth and Mottram can be realised.

Members were advised that work was currently underway with Highways England to cover the opening date on installed signs to indicate that the scheme is currently under review.

It was clarified that a final decision on further public consultation will follow once the new plan has been set out in its initial form and that the approach to a consultation on the future plan would be reported to Greater Manchester local authorities in June 2022.
