#### 1. Introduction

- 1.1 Greater Manchester benefits from an annual devolved Adult Education Budget allocation each academic year (1st August to 31st July) of approximately £96million pounds, and through the 'Level 3 Free Courses for Jobs Offer' (formerly 'Lifetime Skills Offer, National Skills Fund Adult Level 3) GM will receive an additional £8 million of ring-fenced funding (July 2022 to August 2023) to deliver and manage the 'Level 3 Free Courses for Jobs Offer'.
- 1.2 In April 2021, GMCA's Education, Skills and Work directorate launched a GM Local Level 3 Adult Offer to support the needs of the GM Economy and address the restrictions of the national level 3 offer. This local offer is more relevant to GM, is closely aligned to the GM Local Industrial Strategy growth and foundation sectors and attracts full funding for eligible GM residents aged 19 or above. £3 million has been allocated to this provision from the core devolved AEB by GMCA each academic year since 2021/2022.
- 1.3 Closely aligned to those key sectors that support economic growth at a national level, the 'Level 3 Free Courses for Jobs offer' enables residents aged 24 and over to access fully funded, work-focused Level 3 qualifications. 19- to 23-year-olds are also able to access the qualifications made available through this offer, however these are funded through the existing core devolved AEB funding.
- 2. Devolved AEB funding for the Greater Manchester Local Level 3 Adult Offer and devolved 'Level 3 Free Courses for Jobs' offer for 2022/2023

#### **Background and Eligibility Criteria**

2.1 Devolution of the adult skills funding gives an opportunity to bring key parts of the skills system together and reduce the complicated landscape which residents and skills providers are required to navigate. Through the work the GMCA's Education, Skills and Work Directorate have been undertaking over the last twelve months to develop a tailored Level 3 offer for both GM employers and residents, this has highlighted a need and opportunity to 'hide the wiring' which makes accessing the Level 3 qualifications system both complicated to promote and access to the wider GM community.

At the time of writing this report the GMCA's Education, Skills and Work team are currently working with both the GMCA's Commercial Team and Legal to obtain confirmation that the preferred approach would meet all procurement and legal requirements and that this should be decided by the GMCA meeting date.

GM residents aged 19 or above have access to a wide range of Level 3 qualifications to develop the relevant skills and occupational competences needed to:

- support the GM economy,
- gain sustainable employment,
- progress further in the workplace.

Both the local and national Level 3 Adult offers are subject to specific eligibility criteria as summarised in the table below. **Annex 1** provides full details of the complex eligibility criteria and different sources of funding that GM devolved AEB skills providers must navigate to fund Level 3 qualifications.

# GM Local Level 3 Adult Offer

This offer is available for all GM residents aged 19 or above to access specific, fully funded level 3 qualifications, irrespective of their employment or income status, with the option to undertake a second Level 3 qualification if required.

£3m has been made available for the 2022/2023 academic year.

## Level 3 Free Courses for Jobs Offer

This offer fully funds all residents aged 19 or above to undertake a first level 3 qualification from a specified national list.

From April 2022, the rules and eligibility for accessing the Level 3 Free Courses for Jobs offer changed enabling the following residents to undertake a second Level 3 qualification:

- unemployed adults
- adults earning below the GM low wage threshold Just over £8m has been allocated for the 2022/2023 academic year.

GMCA can utilise 20% of the £8 million which has been allocated for the 'Level 3 Free Courses for Jobs' offer in 2022/2023 for locally specified level 3 activity. Applying this national funding to local demand enables the Education, Skills and Work directorate to further address our local employer needs, drive up demand from residents and begin to change the behaviour of our adult skills providers. GMCA work with the ESFA to agree a locally defined list of Level 3 qualifications against which the 20% can be used.

19- to 23-year-olds accessing qualifications from the 'Level 3 Free Courses for jobs offer' are funded through core devolved AEB.

This adds a significant burden to providers and impacts on their core allocations, hence GMCA's ESW team allow this provision to be funded through the ring-fenced GM Local Level 3 offer as an alternative.

2.2 The Education, Skills and Work directorate monitor the overall level 3 qualification spend by providers against their approved allocations throughout the year and adjust funding accordingly where delivery is above or below profile. It should be noted that this is both a complex and labour-intensive process.

#### Proposal for the 2022/2023 Academic Year and onwards

2.3 GMCA's Education, Skills and Work team are proposing a mechanism which streamlines the funding and how Level 3 qualifications will be marketed to the wider GM Community, subject to approval and ongoing discussions with GMCA's Commercial Team and Legal Support (Manchester City Council). The proposed methodology is:

Simplify the level 3 funding system to make funding available through a dynamic 'single pot' approach allowing adult skills providers to support employers and residents based on need and demand that is aligned to the GM economy as follows:

- All GM Local Level 3 and 'Level 3 Free Courses for Jobs offer' activity to be funded through a single pot of money amalgamated from both funding sources for the 2022/2023 academic year and onwards.
- All existing AEB skills providers will have the opportunity to deliver Level 3
  qualifications from the GM Local Level 3 offer and the 'Level 3 Free
  Courses for Jobs offer' lists.
- Providers will not be given a specific allocation for either the individual funding sources or the 'single pot', however they will have a restricted upper value to work towards in line with national procurement rules.
- o GMCA's Education, Skills and Work team will centrally manage the funding streams throughout the year to ensure that each of the level 3 funding sources are maximised and the complexity of the funding sources and eligibility requirements are managed centrally rather than by individual providers and learners, hence reducing the level of bureaucracy.

- 2.4 The Education, Skills and Work team considers the proposed methodology to be the preferred route as:
  - It simplifies a complex system for AEB skills providers and offers greater flexibility.
  - It maximises the range of level 3 qualifications available for employers and GM residents to access with a greater emphasis on the Foundation and Growth sectors of the GM economy.
  - It will be managed centrally by the GMCA's Education, Skills and Work team
    which would be less labour-intensive than monitoring individual contract
    allocations and performance and funding sources will be maximised where
    possible.

#### 2.5 GMCA are asked to:

- Consider and note the proposed approach as outlined above.
- Delegate authority to the Monitoring Officer to execute all the necessary agreements, to distribute devolved AEB and National funds for a Single Pot Level 3 Offer for Greater Manchester residents and employers for 2022/2023 onwards.
